LIMITED WARRANTY

If defective in material or workmanship your mattress will be repaired or replaced at our option in accordance with the Limited Warranty Schedule. Any and all implied warranties on this product shall not exceed the schedule of Limited Warranties on your model number.

LIMITED WARRANTY COVERAGE DETAIL

This Limited Warranty on Memory Foam covers the following: Deterioration of the cell structure within the memory foam, sagging or Body impressions that measure greater than 1 1/2" will be covered as long as the memory foam mattress is on a solid foundation. Normal Body Impressions less than 1 1/2" is a normal function of memory foam mattresses.

All other claims including incidental or consequential damages are excluded. If the original materials are not available at the time of repair and or replacement, the manufacturer reserves the right to substitute materials of comparable quality.

Spring Mattresses are warranted against any broken or loose wires protruding through the fabric and any Body depression and sagging that measures greater than 1 1/2" deep.

This warranty begins on the first day of your purchase. If your mattress is repaired or replaced, this limited warranty will not be renewed or extended.

LIMITED WARRANTY VALIDATION

1. Must be the original consumer or purchaser, and have purchased the mattress from one of our authorized dealers.
2. Must Provide a copy of the original sales receipt with date of purchase.

ITEMS NOT COVERED IN THE LIMITED WARRANTED

- * Fabric Stains, soiling, tears, cuts or burns
- * Mattress fabric
- * Corner guards
- * Comfort preference
- * Sagging in the mattress that measures less than 1 1/2"
- * Body impressions less than 1 1/2"
- * Memory Foam and Latex Mattresses: The normal change in softness overtime
- * Damage of the mattress due to misuse or abuse including but not limited to damages due to moving or bending
- * Mattress damage due to an inappropriate foundation or when an incorrect bed frame is used
- * Bedding used in hotels, motels or institutional facilities
- * Floor samples or Bedding sold "as is", Promotional and or clearance items
- * All transportation and inspection costs
- * The cover to your AmeriMattress mattress is not covered under the warran

TIPS FOR BEDDING CARE

- » Do Not allow your mattress to be exposed to liquids, water or other fluids may damage upholstery causing materials to compress.
- » Keep your bedding clean; it is recommended to use a mattress pad. Stain, soiling, infestation or other signs of abuse may void the warranty and make your bedding ineligible for repair or replacement.
- » Do Not use cleaning chemicals or treatments on your mattress. The chemicals may damage some of the materials.
- » Do Not smoke in bed
- » Do Not use candles nearby or on bed.
- » Rotate your mattress as needed, this will promote even wear.
- » Use a matching foundation to ensure validation of your warranty.

Starting in the eleventh (11th) year, the prorated repair or replacement charge will be fifty - five percent (55%) of the original purchase price. The prorated charge will increase by five percent (5%) for each subsequent year of the prorated period. |
| 407 | 20 | During the first five (5) years we will repair or replace at no charge to the original purchaser. Starting in the sixth (6th) year, the prorated repair or replacement charge will be thirty percent (30%) of the original purchase price. The prorated charge will increase by five percent (5%) for each subsequent year of the prorated period. |
| 603 / 618 620 / 630 | 30 | Starting in the first (1st) year, the prorated repair or replacement charge will be 1/30 of dealer retail price times number of years of use. |
